## 2020 Candidate Survey with Yes or No Answers

1. Are you publicly and privately opposed to all abortions, regardless of circumstance of conception, such as rape or incest?
2. Is it permissible to intentionally and directly abort a baby to "save" the life of a mother?
3. Do you support artificial formation of human life outside the womb for the purpose of cloning, fertility treatment such as in-vitro fertilization, and embryonic stem cell research?
4. Do you believe that at the moment of fertilization there is a living, unique and unrepeatable human being present in the womb?
5. Is it permissible to abort babies based on sex selection or a diagnosis of a deformity or disease?
6. Will you advocate for and support government efforts that recognize and uphold the inalienable right to life, endowed by Our Creator, for pre-born children from the beginning of their biological development -- the moment of fertilization?
7. Have you or would you ever accept money from any group or PAC that supports abortion, euthanasia, or assisted suicide?
8. Will you work politically to end the trafficking of all baby body parts obtained from abortion?
9. Will you work to protect the rights of pro-life citizens as they demonstrate peaceably and legally against all abortion providers, nurses, advocates, judges and others who promote abortion and euthanasia?
10. Will you support and endorse legislation that provides conscience protection to health-care providers so they are free from statutory and regulatory mandates that would otherwise require them to provide, participate in, or make referrals for services that conflict with their morals?
11. Will you support legislation that prevents or removes government mandates that force health care plans to include "free" coverage of abortifacient birth control and sterilization as well as education and counseling on these "preventative services"?
12. Do you support a ban of all tax-payer funding of Planned Parenthood and other abortion providers through Medicaid or other state or federal funding?
13. Will you oppose spending bills that fund organizations that perform abortions?
14. Do you support unethical or unfettered bioethical research?
15. Will you vote as you have indicated on this questionnaire when you have the opportunity to protect life?
16. Will you courageously help lead continued legal and political efforts to acknowledge that the word "person" includes each and every human being from the moment of conception?
17. Will you vote to stop advancement or ratification of the Equal Rights Amendment in the Nebraska Constitution or the United States Constitution?
